DIRECT DEBIT REQUEST (DDR) CUSTOMER (DONOR) AUTHORITY

1. Debiting details are provided on the "Direct Debit Request" form. 2. The Customer (donor) will be advised in writing 14 days in advance of any changes to the Direct Debiting arrangements. 3. For changes or other matters relating to Direct Debit arrangements, the Customer (donor) will need to call WPSA on (02) 9556 1537 or write to PO Box 42, Brighton Le Sands NSW 2216 or email info@wpsa.org.au. 4. WPSA will follow the following process for returned unpaid transactions: a) WPSA will advise the Customer (donor) of the unpaid transaction and request alternative arrangements to be made for payment if possible. b) The deduction will then be made on a subsequent day typically in five working days 5. All Customer (donor) records and account details will be kept private and confidential to be disclosed only at the request of the Customer (donor) or Financial Institution in relation to a query of possible incorrect or wrongful debit. 6. This authorisation is to remain in force until it is cancelled by the Customer (donor). The Customer (donor) should provide 14 days notice for direct debit cancellations and follow point 3 of the "Direct Debit Request" Form. 7. Deductions will be made on the 15th of each month. 8. If the 15th is a public holiday the deduction will be made on the next working day.
